Minutes of the General Assembly of the BME Club of 13th May, 2011 at Kursraum 1, Kinderklinik, Inselspital, Bern.

1. Welcome by the president

The president Prabitha Urwyler opened the meeting and welcomed the participants. 24 members of the BME club attended the General Assembly.

2. Approval of the agenda

The agenda of the second General Assembly was approved unanimously.

3. Election of the day's chairman

Tobias Nef was elected unanimously as the chairman of the General Assembly.

4. Election of the protocol recorder

Christoph Reutlinger was elected unanimously as the protocol recorder.

5. Approval of the minutes of the last assembly

6. Activity report

A trip to the MEDICA in Düsseldorf was arranged, which was attended by 30 students and club members. A visit to the MEDICA will be offered this year as well. Furthermore, the morning talks, organized by the Medical Cluster, can now be attended by the BME Club members. The activity report (enclosed/attached) was approved unanimously.

7. Approval of new club members

The BME Club currently has 174 members of which 87 are students. The membership of 21 new regular and 17 new student members was approved with a large majority.

8. Financial report and budget 2011/2012

The treasurer Christian Güder presented the financial report. The assets of the BME Club are 10.624,75 CHF. The internal auditors, Patrick Roth and Lutz Nolte, confirmed the financial situation of the BME Club. The financial report was approved by the majority of the members.

9. Election of the executive members

Tom de Bruyne was elected for the position of the vice-president. The rest of the office bearers continue in their positions and were approved by the majority of the members.
